The Role

Our market season at Hillsdale runs April 12th-November 22nd 2026; additional on-farm work may be available on a seasonal basis, with potential to build into a full-time seasonal position.

This position is primarily responsible for safely delivering products to the market in good condition, while representing GTF in a positive, professional manner and providing great customer service at the market. Experience in retail, and with fresh produce is highly desired.

This Sunday shift is a long day - typically 12 hours, from approximately 4:30am to 4:30pm. Markets are bustling, busy, but rewarding work environments. You will be working alongside a team of experienced coworkers who are passionate about good food, you will build great trading relationships with other vendors, receive paid breaks, and an abundance of organic produce for your household.

Responsibilities:

- Operate a 24 ft. box truck in the city streets of Hillsdale
- Delivering produce and market supplies to market in good condition
- Unload produce and market supplies using safe ergonomics
- Participating in working the market by assisting customers in selecting and purchasing produce
- Load the remaining produce and all market supplies in truck
- Securely transport market cash and supplies to GTF office
- Beware of and follow specific Farmers Market's policies

Minimum Requirements:

- Physically capable of standing for long periods of time, lifting totes up to 50 lb, moving heavy display racks and materials above shoulder height.
- A Valid Oregon Driver's License is required; for insurance purposes, no moving violations permissible in the previous 2 years
- The ability to safely and confidently operate a 24 ft. Automatic box truck. (We can train someone without big truck experience, but who is willing to learn)
- The ability to safely and confidently operate manual or electric pallet jacks (again, we can train someone who is willing to learn)
